Dear Representative:

I wanted to reach out to you to let you know I fully support the passage of Senate Bill 1658 sponsored by Senator Bolick. SB 1658 would finally provide law enforcement with the clear, enforceable standards they need to protect companion animals in critical need. This bill would give law enforcement the tools necessary to hold the bad guys accountable because our current laws are too vague and fail to provide even bare minimum protection in animal cruelty cases.

As Sheriff of Maricopa County, I saw many egregious animal cruelty cases while fighting crime and working to make our communities safer. We seized a lot of animals during my 24-year tenure as sheriff. I always told my deputies if they find people breaking laws against animals, there is always room for them in my jails.

During my time as Sheriff, I established the Maricopa County Sheriff Office's Animal Safe Haven (MASH). This special unit, which was established in 2000 and still exists today, houses animals seized during MCSO investigations, providing care, feeding and shelter for "evidence" animals that have suffered abuse and neglect. The MASH unit heals and rehabilitates neglected and abused animals, nurtures them back to health and adopts them out to loving, forever homes. Much of the animal care is provided by inmates, giving inmates the opportunity to learn to work with animals and develop life skills, while developing empathy, purpose and compassion. Participating inmates gain life-changing opportunities for personal growth and achievement.

In 2006, I worked with the Arizona Humane Society to support Proposition 204, the Humane Treatment of Farm Animals Act on the statewide ballot. I believe all animals deserve to be treated with respect. But to be clear, nothing in this bill impacts farm or agriculture. This bill strictly relates to companion animals, which is very much needed right now given the stark and concerning rise in animal cruelty against pets.

If you don't know by now, I have a real heart for animals. I despise cruelty in any form and have fought and will continue to fight for stronger laws to crack down on animal cruelty.

Let's not allow people to treat animals in a way that causes them to suffer. Please vote yes on SB 1658 when it comes to the House floor for a vote.
